Sería del caso impartir aprobación a la liquidación de crédito presentada por el extremo demandante, que incluye un capital de \$32.528.824,95, réditos de plazo de \$2.389.885 y de mora de \$13.694.852,79, comoquiera que dentro del término previsto en el artículo 446 del Código General del Proceso, no fue objetada.

Sin embargo, se observa que los réditos de mora se calcularon con una rata superior a la pactada; de modo que, el despacho procede a modificarla, de la siguiente manera:
