Pereira, tres (3) de febrero de dos mil veintiuno (2021)

Procede la Sala a decidir sobre la viabilidad del recurso de casación interpuesto por **Itaú Corpbanca Colombia S.A.**, contra la sentencia proferida el 19 de agosto del año 2020 en este proceso ordinario laboral que le promueve el señor **Adalberto Galvis Rendón**.

Para el efecto es imperativo considerar que de conformidad con lo establecido por el artículo 86 del Código Procesal del Trabajo y de la Seguridad Social, en materia laboral sólo son susceptibles de dicho recurso los procesos cuya cuantía exceda de ciento veinte [120] veces el salario mínimo legal mensual vigente, suma que actualmente asciende a **\$105.336.360**.

De otro lado, ha de tenerse en cuenta que el interés para recurrir en casación tiene relación directa con el valor del agravio causado al recurrente por la sentencia de segunda instancia.

En el asunto bajo examen la sentencia de segundo confirmó la de primer grado que ordenó la nivelación salarial a favor del actor y como consecuencia de ello condenó a la entidad bancaria a cancelar a su favor la suma de **\$24.611.967** correspondiente al reajuste de salarial y prestacional de carácter legal y extralegal y además a completar los aportes pensionales con base en el salario realmente devengado -condena esta última que de acuerdo con la tabla anexa arroja un total **\$6.139.749-**.

Puestas así las cosas es claro que el interés para recurrir en casación resulta inferior al límite mínimo requerido para hacer viable el recurso, por lo que se denegará.

En mérito de lo expuesto, la **Sala de Decisión Laboral del Tribunal Superior del Distrito Judicial de Pereira, DENIEGA** el recurso de casación formulado por la parte demandante contra la sentencia proferida en este proceso el 19 de agosto de 2020.
