La primera cuota iniciará el 1 de agosto de 2016, y así sucesivamente, según el incremento del salario mínimo legal mensual decretado por el gobierno Nacional, comenzando en el mes de enero de 2017. En caso de que el padre de la menor cambie de vinculación laboral el aporte alimentario será del 12.5% del salario devengado, previas deducciones de ley.

Vestido: Ambos padres darán a su hija menor cuatro (4) mudas completas al año, una en el mes de junio, dos en diciembre y la otra en la fecha de su cumpleaños, las cuales ascenderán a la suma de DOSCIENTOS MIL PESOS (\$200.000) cada una. Comenzando en el mes de diciembre de 2016..."

En este orden se tiene:

1. Del mes de enero del 2018 al mes de febrero inclusive del 2019. Lapso durante el cual, el

demandado laboro en la iglesia Santa Cecilia de New Jersey. Por cuanto, cuando se elaboró el acuerdo el demandado laboraba en dicha iglesia. Conforme se estableció en el acuerdo de pago, pagaría Un millón ciento sesenta mil pesos mensuales (\$1.160.000).

Luego, de enero del 2018 a febrero inclusive del 2019. Lapso durante el cual, el demandado laboro en la iglesia Santa Cecilia de New Jersey. Se establece el primer Ciclo. Para el efecto contabilizamos lo pagado de acuerdo a lo relacionado en el cuadro aportado con la contestación de la demanda. Vamos a establecer la diferencia que existe entre lo que se pagó y lo que se relaciona en el mandamiento de pago. Recordando que son 13 meses con una cuota \$1.160.000 cada mes. Teniendo en cuenta la variación del costo de vida para el año 2019 se incrementa.

Para el primer ciclo se pudo establecer perfecta concordancia entre lo consignado en dólares y lo recibido por la demandante. Solo se diferencia en la respectiva cotización del dólar. Luego, aplicando el acuerdo de pago: "En caso de que el padre de la menor cambie de vinculación laboral el aporte alimentario del salario devengado, previas será del 12.5% deducciones de ley." Por lo que, se contabiliza en esta segunda fase lo que debía pagar de cuota alimentaría, conforme con el acuerdo de pago, teniendo en cuenta que, al no tener salario fijo ni empleo estable, acorde con la ley colombiana se debe tomar el salario mínimo legal vigente. Luego, para este lapso de marzo de 2019 hasta enero inclusive de 2020. Se contabiliza el 12.5% mensual de este salario mínimo (2019 - 2020) y se confronta con lo pagado a la madre de la menor que se relacionó en el cuadro que se aportó con la respuesta de la demanda.

Para este segundo ciclo se pudo establecer perfecta concordancia entre lo consignado en dólares y lo recibido por la demandante. Solo se diferencia en la respectiva cotización del dólar. Por ello, se asume lo relacionado por la apoderada de la demandante en el escrito de respuesta a las excepciones. Donde se tiene que fue consignada la suma de \$ 2.458.026, por concepto de cuotas alimentarias de marzo a enero de 2020 inclusive. Frente al debido pagar de \$ 1.144.870, Se tiene un saldo a favor de \$.1.313.156....

Durante este periodo el demandado consigno en efectivo la suma de \$ 1.473.171, Así mismo, compró mercados, al supermercado se ingresaba con la tarjeta de membresía de la demandante y normalmente ingresaban ambos a realizar las compras de mercado y víveres.

laboró Durante ese lapso en la Compañía de New Jersey en el área de limpieza medio tiempo en la noche. Por lo cual devengaba por horas laboradas. Durante este lapso devengó de US 14.313 dólares antes de impuestos, quedando un rubro neto después de impuestos de US 12.400 dólares.

En este orden, se divide 12.400÷8 =US1.550 dólares mensuales, a lo cual, se aplica el 12.5% conforme acuerdo aprobado al Juzgado. Corresponde el debido a pagar la suma de \$5.942.633, se le resta lo consignado en efectivo el valor de \$1.473.171. nos da un saldo provisional del debido pagar de \$ 4.469.462. al compensar lo pagado en víveres y mercado desde el 10 de febrero del 2020 al 18 de agosto del 2020 (donde vivían los tres) corresponde a la suma de \$ 9.172.377.

Rubro que al deducirse la suma de \$9.172.377 - \$4.469.462 da un saldo a favor de \$ 4.702.915.
