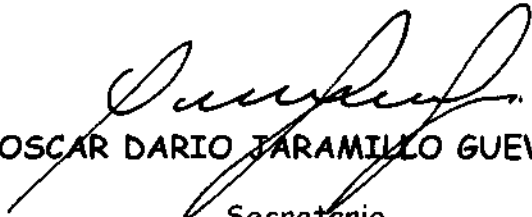


CONSTANCIA SECRETARIAL
