LEGITIMIDAD DEL EXTREMO PASIVO PROPONENTE DE LA NULIDAD

En mi calidad de apoderado judicial del señor **MASSIMILIANO AGELAO**, parte demandada dentro del proceso de la referencia, me encuentro legitimado según el poder conferido por mi representada para solicitar el decreto por parte de su despacho de la nulidad que se invoca a través de este medio de defensa.

CAUSAL INVOCADA PARA DECLARAR LA NULIDAD

La causal que se invoca como fundamento para decretar la nulidad por parte de su despacho es la siguiente:

*“Ley 1564 de 2012. Artículo 133 No. 8. Cuando no se practica en legal forma **la notificación del auto admisorio de la demanda a personas determinadas**, o el*

emplazamiento de las demás personas aunque sean indeterminadas, que deban ser citadas como partes, o de aquellas que deban suceder en el proceso a cualquiera de las partes, cuando la ley así lo ordena, o no se cita en debida forma al Ministerio Público o a cualquier otra persona o entidad que de acuerdo con la ley debió ser citado”.

HECHOS QUE SOPORTAN LA SOLICITUD DE NULIDAD

1. El día 11 de marzo del año en curso, le fue enviado a mi representado por su red social WhatsApp, una providencia de fecha 9 de marzo del 2023.
2. En este auto, proferido por el juzgado 4 Civil del Circuito de Santa Marta, se resolvió en sus primeros tres numerales lo siguiente:

“.. PRIMERO: Reconocer personería a la doctora SOL YARINA ALVAREZ MEJIA, como apoderada judicial de la sociedad demandante, en los términos y efectos del poder conferido. SEGUNDO: ATENDER los actos de notificación realizado por la parte demandante, para lograr el enteramiento de la demanda y del auto admite el proceso Verbal de Restitución de Tenencia –Leasing Habitacional, presentada por el BANCO DAVIVIENDA S.A. contra el señor MASSIMILIANO AGELAO. TERCERO: INFORMAR a las partes que en el presente asunto se proferirá sentencia anticipada conforme el numeral 2º del artículo 278 del Código General del Proceso, teniendo en cuenta que no existen pruebas por practicar....”

3. Mi representado, señor **MASSIMILIANO AGELAO**, no ha recibido a la fecha notificación personal del auto admisorio de la demanda.
4. Es relevante y determinante señalar, que mi mandante hace más de 1 año y 8 meses, vive en el exterior, reportándose la salida del país, desde el 26 de junio del 2021.
5. Mi representado no se ha notificado de la acción de la referencia, mucho menos contestar la demanda, y presentar las excepciones del caso, toda vez que desde hace más de 1 año se encuentra viviendo en el exterior.

6. Desde esa fecha hasta el día de hoy mi representado no ha regresado al país, empero ha mantenido comunicación, a través de sus delegados, con el Departamento Comercial de la Demandada.
7. La demandada ha tenido contacto a través de su correo electrónico con mi mandante, con la cual se han hecho acercamiento para comercialmente llegar a un arreglo, sin embargo nunca le remitieron notificación por aviso alguna de la presente demanda.
8. La demandante tiene pleno conocimiento, que mi representado hace más de 1 año y 8 meses no reside en el país.
9. El inmueble donde objeto de la presente acción, se encuentra deshabitado hace más de 1 año y 8 meses.
10. Cualquier acto procesal de notificación dirigido a la dirección del inmueble objeto de esta Litis es ineficaz, por no encontrarse habitado por mi representado.
11. En aras de hacer uso del derecho a la defensa y contradicción, de raigambre superior, y consagrado en nuestro estatuto procesal civil, mi representada me confiere poder el día 12 de marzo de este año, el cual se radico de manera inmediata en su despacho a fin de representar y defender los intereses y derechos de mi mandante.

FUNDAMENTOS JURIDICOS

Artículo 132 y s.s. del Código General del Proceso. Y adicionalmente, a continuación, se expondrán unos extractos jurisprudenciales sobre la materia.

La vinculación del demandado al proceso es asunto de particular importancia, por constituirse en un factor protuberante en el cumplimiento del derecho fundamental constitucional al debido proceso, por ello la correcta notificación de la demanda

marca el momento que en que se traba la relación jurídica procesal entre las partes. Por ello el legislador ha querido que el momento procesal de la notificación este rodeado de todas las formalidades prescritas en la ley, para que dicha actuación se surta en debida forma. (*Hernán Fabio López, Código General del Proceso, Parte General, 2017*)

En este sentido, se tiene que para el caso particular, mi mandante nunca ha sido notificada del auto admisorio de la demanda en legal y debida forma, dando lugar a la causal de nulidad invocada de que trata el numeral 8 del artículo 133 del CGP, al no realizarse de manera legal la notificación del auto admisorio.

Respecto a las nulidades la Corte Suprema de Justicia en su sala de casación civil se ha pronunciado en el siguiente sentido:

*“..Con relación a los principios que caracterizan este medio de defensa, tenemos los siguientes: “El de especificidad, según el cual las causas para ello sólo son las expresamente fijadas en la ley; de protección, relacionado con el interés que debe existir en quien reclame la anulación, emergente **del perjuicio que el defecto le ocasione**, y de convalidación, que determina que sólo son declarables los vicios que no hayan sido, expresa o tácitamente, saneados por el interesado...” (CSJ, SC del 6 de julio de 2007, Rad. n.º 1989-09134-01).*

En este orden de ideas, la carencia de la notificación en debida y legal forma a mi mandante, no solo esta cercenando sus derechos fundamentales al debido proceso y a la defensa, sino que también, le está ocasionando perjuicios en otras aspectos procesales, al verse expuesta a las resultas de un proceso, que, de no decretarse la nulidad invocada y sustentada por este escrito, podría afectar eventual y gravemente su peculio patrimonial y ocasionar de igual manera daños extra patrimoniales.

Ahora bien, esta solicitud de nulidad se constituye en el primer acto procesal desplegado por la defensa de mi representado, y como quiera que es nuestra primera oportunidad de intervenir en el proceso, habida cuenta de que se encuentra vencido el termino para la contestación de la demanda y la proposición

de excepciones de mérito y previas, ponemos en conocimiento de su despacho las actuaciones irregulares que se han venido presentando en el curso del presente proceso, para que bajo la óptica de los principios de legalidad, debido proceso, defensa, entre otros, se sirva conceder la petición invocada a través de esta solicitud. Lo anterior, encuentra asidero en un aparte jurisprudencial de nuestra honorable Corte Suprema de Justicia sala de casación civil:

*“Como lo reiteró la Corte, ‘so pena de entenderlas saneadas’, lo dicho ‘**imponer a la parte agraviada con el vicio procesal la obligación de invocar, en la primera oportunidad que se le brinde, no sólo todas las causales anulatorias que a su juicio se han estructurado, sino también todos y cada uno de los hechos, motivos o razones que las configuran**’ (CSJ, SC del 1º de marzo de 2012, Rad. n.º 2004-00191-01; subrayas y negrillas fuera del texto).*

PRETENSIONES

En mérito de todo lo expuesto.

PRIMERO: Revocar en todo y cada uno sus apartes, el auto de fecha 9 de marzo del 2023, y como consecuencia decretar la nulidad de todo lo actuado dentro del proceso de la referencia, desde el auto admisorio de la demanda.

SEGUNDO: En Caso de confirmarse su decisión, se me conceda el recurso de apelación ante el Honorable Tribunal Superior del Distrito Judicial de Santa Marta – Sala Civil.

TERCERO: Se me dé traslado del auto admisorio de la demanda, la demanda y sus anexos.

CUARTO. Se me reconozca personería para actuar.

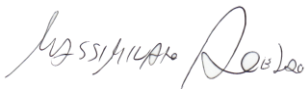

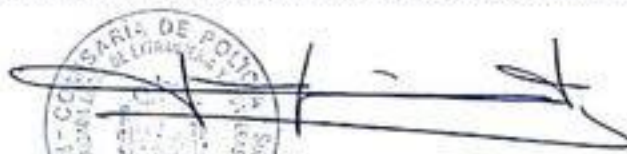
