Visto y verificado el informe secretarial, este despacho examinó la liquidación del crédito presentada por el apoderado de la parte demandante, se pudo establecer que la misma sobrepasa los parámetros establecidos por la SUPERFINANCIERA, por lo que se procederá a realizar la liquidación del crédito, teniendo en cuenta la tasa permitida por la ley.

Lo anterior por cuanto el apoderado de COOPVIPEBA, al momento de presentar la liquidación del crédito, manifestó que era igual a VEINTISIETE MILLONES NOVECIENTOS VEINTE MIL PESOS CON CERO CENTAVOS (\$27.920.000,00), producto de:

- La suma del capital adeudado OCHO MILLONES PESOS CON CERO CENTAVOS (\$8.000.000,00); más
- UN MILLÓN CIENTO CINCUENTA Y DOS MIL PESOS CON CERO CENTAVOS (\$1.152.000,00); producto de los intereses corrientes generados más;
- DIECIOCHO MILLONES SETECIENTOS SESENTA Y OCHO MIL PESOS CON CERO CENTAVOS (\$18.768.000,00); producto de los intereses moratorios generados;
